Only the first 64,500 tickets will be used for this raffle drawing. The drawing for the grand prize will be open to the public, but the winner does not need to be present to win. Your chances of winning are based on 64,500 tickets sold. If fewer tickets are sold, your chances of winning improve. If you purchase more than one ticket, your chances of winning improve. A minimum number of tickets must be sold to release the Free Gas for 10-Years\* prize, as defined in the GRAND PRIZE RULES below.

### **GRAND PRIZE RULES**

A maximum of 64,500 tickets will be sold and entered into this drawing. If more than 64,500 tickets are sold before the drawing date of August 31, 2008, those tickets that were sold after the first 64,500 tickets will be automatically entered into a second raffle drawing, in lieu of and instead of being entered into this drawing. The date of the second raffle drawing will be determined by THE ORPHAN FOUNDATION based upon the number of remaining raffle tickets needed to be sold, but in no case, will the second drawing be held later than December 31, 2008. Should a subsequent raffle be determined necessary, similar rules to this raffle will apply in that subsequent raffle, except for any dates mentioned in these rules. If a second drawing is necessitated, the new drawing, notification and payout dates will be announced by September 30, 2008.

A minimum of 15,000 tickets must be sold for the grand prize of *Free Gas for 10-Years\** to be awarded as defined below. The calculated payouts shown below are based on a maximum of 15,000 driven miles per year, with a minimum fuel economy of 18 miles per US gallon, and a maximum gas price per US gallon in the first 12 months of \$4.00. In each subsequent year, the payout will reflect an increase of 10% in the maximum gas price per US gallon, capped in value at that amount, and paid out exactly as shown below:

The above payout amounts will be made on or about September 15<sup>th</sup> of each of the 10 years, beginning September 15<sup>th</sup>, 2008, with a payment of \$3,333.33. On September 15<sup>th</sup> of 2009, a payment of \$3,666.67 will be made to the grand prize winner, and so on, until the final payment of \$7,859.83 is made on September 15<sup>th</sup> of 2017. The total of these payments will equal \$53,124.75. THE ORPHAN FOUNDATION will not place any restrictions on the use of the monies paid to the grand prize winner, except that the monies must be easily transferred to the individual or entity by check or electronic deposit. Alternatively, the winner may choose to take a one-time, upfront payment of \$39,500.00, which is the Net Present Value (NPV) of the payout amount, using an NPV rate of 5%. There shall be no other calculation of NPV allowed, and the winner agrees to be bound by this decision, if he or she elects the upfront payout of the grand prize.

If fewer than 15,000 raffle tickets are sold by August 31, 2008, the raffle will be held as scheduled, and the grand prize winner will receive a 50% share of the net raffle proceeds instead of the *Free Gas for 10-Years\** Prize. Net raffle proceeds are defined as the balance of funds left after paying

all other prizes and all raffle expenses. Net raffle proceeds will be divided evenly between THE ORPHAN FOUNDATION and the grand prize winner, less appropriate and required federal taxes.

THE ORPHAN FOUNDATION will withhold the appropriate and required federal and state taxes in accordance with applicable law, and THE ORPHAN FOUNDATION will remit the balance of the cash prize to the grand prize winner.

The grand prize winner must make an election in writing between the scheduled 10-year payout schedule, and the upfront cash payout, no later than 3 p.m. on September 10<sup>th</sup>, 2008.
